<sup>2</sup>Graduate Assistant's portion of the Mandatory Health Insurance is estimated at \$830.

<sup>3</sup>**SUMMER ESTIMATES** - Full-time summer expenses are figured by adding \$950 (books and supplies), \$500-\$1000 (fees), and the amount of your tuition which is 9 times the summer per credit cost for graduates and 12 times the summer per credit cost for undergraduates. <sup>4</sup>If **accompanied by dependent** spouse or children, you are fully responsible for their support and additional funds are required. The cost of insurance for a dependent is equal to the cost of the student. Graduate rate listed. University assistantship stipends are not sufficient to cover dependent expenses and are not intended to do so.

**The high cost of child care for children ages 0-6 years is not included in the child expenses figures.**

<sup>5</sup>Graduate Assistant child dependent expenses are \$4,600 (\$1,050 @ 25%) for each of the first 2 children, with a maximum of \$2,100 insurance for 3 or more children.
